Our Strategy 2024-2028

Environment Victoria's strategy operates on a rolling four-year time horizon with reviews every two years providing the opportunity to update assumptions and change course where necessary. In 2024 we updated the plan and extended it to 2028.

Our Purpose:

We are building a movement of people across Victoria to create a just society living in harmony with a healthy environment.

Our Role:

We are a campaigning organisation that wins just solutions to the biggest environmental problems in Victoria. We make change through:

- Growing a diverse network of empowered volunteers who organise and mobilise their communities
- Collaborating with other organisations and networks to build a bigger movement for environmental justice
- Acting as a trusted voice and influential advocate to decision-makers
- Changing the public conversation to make big change possible by exposing hidden injustices, discrediting false solutions and elevating real solutions
- Running strategic and focused people-powered campaigns to win systemic change

Our Values:

Love – inspired by love for people and nature in everything we do, we focus on what connects us and builds commitment to the common good

Justice – working to redistribute power and resources, we strive for equity, empowered communities and First Nations self-determination

Courage – despite difficulty and uncertainty, we act with integrity and do what it takes to meet the challenges we face

Innovation – we approach our work with curiosity and humility, always looking for opportunities to learn

Impact – we are transparent in our decision-making and focused on getting results for our community and environment

Our Goals:

Over the next four years we will be working towards:

- A fast and fair transition from fossil fuels to renewable energy by securing a just transition beyond coal in the Latrobe Valley, accelerating the renewables build with Free, Prior and Informed Consent of First Nations and kick-starting Victoria's transition off gas and fossil fuelled transport.
- First Nations leading the restoration of country by building the national campaign to secure a revitalised Murray-Darling Basin Plan and nurturing a growing local movement in support of biodiversity and First Nations land and water justice.
- A strong, cohesive and diverse Victorian environment movement by growing the skills, leadership, diversity and reputation of a network of grassroots environmental leaders around the state and defending the space for activism and democratic engagement.
- A creative, resilient and inclusive organisation capable of driving real change at the scale we need by investing in our people, growing our base and safeguarding our independence.















A Message From Our President and CEO

Change is never easy, and big change is especially hard fought. Which is why it's so important to celebrate progress when it occurs. This year, Environment Victoria helped set a globally significant precedent in the fight for a safe climate. One that many thought was impossible. We secured a world-leading gas phase-out plan for homes and commercial buildings, right here in Australia's most gas-dependent state. It's turning heads around the world, and it's something everyone in the Environment Victoria community should be proud of.

The fact that fossil fuels are so entwined in our lives makes the transition to clean energy complex technically, socially and politically. Simplistic solutions like Peter Dutton's nuclear fantasy seem to offer a short-cut, but in reality they're dangerous distractions. We're proud of our efforts to ensure this disastrous policy was soundly rejected by voters at the May federal election. We mounted our biggest federal election campaign in many years, helping not only demolish support for nuclear but also secure in its place a massive \$2.3bn package for households to install batteries.

It was a momentous year in Victoria's journey to Truth and Treaty. A solemn contingent of Environment Victoria staff and supporters joined Commissioner Travis Lovett and thousands of Victorians to mark the delivery of the Yoorrook Justice Commission's final report on the impact of colonisation. Our organisation was formed half a century ago to challenge environmentally harmful

practices. As the Commission's findings clearly show, these practices – from clearing forests to draining wetlands and rivers – have also been acts of theft and desecration. Going forward, the solutions we seek must not only repair our natural world but restore the rights and the dignity of First Peoples. Our work for a healthy Murray-Darling, and to rehabilitate the Latrobe Valley coal mines put this principle in practice. We cannot change the past, but we can choose to walk together into a more just, harmonious and sustainable future.

Of everything we worked together to change in the world, perhaps the thing that we should be most proud of is how we enabled a growing number of people to be part of that change this year. Over 2,500 people gave their first ever gift to Environment Victoria, and many generous donors made their largest ever contribution. Our Action Network held its biggest training summit ever, and this year staff took the back seat in many sessions as skilled long-term volunteers led high quality workshops, inspiring newcomers to step into leadership themselves. It was also our most culturally diverse summit yet, with a third identifying as First Nations or a person of colour.

Thank you to every one of our supporters, who powered our work with their time, their money, their skills and their networks. It has been, as always, an incredible honour to work with you.

Victoria Beyond Coal

We're holding coal companies accountable, exposing nuclear and coal-to-hydrogen as dangerous distractions, and pushing for a fast, fair energy transition in Gippsland.

Nuclear-free Gippsland

When Peter Dutton named the Latrobe Valley as a potential nuclear reactor site, we supported the local community to deliver a powerful response that was heard across the country.

Together with local allies, we spoke to the community at public stalls, handed out thousands of flyers, hosted a packed community forum, delivered petition messages on giant sunflowers to the local MP, and amplified community voices across local, state and national media. This was backed up with eye-catching billboards in Traralgon and a targeted digital advertising campaign.

The campaign grew our local Action Network, strengthened community relationships, and sent a clear message: Gippsland wants clean energy solutions, not another toxic distraction.

Mine rehabilitation and water justice

The Environmental Effects
Statement process for ENGIE's
Hazelwood mine was delayed
this year, but the other coal mine
operators, Energy Australia
and AGL, were invited to apply
for water entitlements for
rehabilitation. We continued
our push for transparency on
water pricing, including backing
a Freedom of Information
request by Friends of Latrobe
Water to reveal how little mining
companies expect to pay for this
public resource.

This work led the new Victorian Water Minister to reconsider water pricing for mine rehabilitation, providing an opportunity for greater transparency and funding for river restoration projects. We also strengthened our relationships with Traditional Owners and other local stakeholders, building a foundation for more community-led action on water entitlements and rehabilitation plans in the coming year.

No public funding for HESC

The disastrous Hydrogen Energy Supply Chain (HESC) proposal to convert brown coal into hydrogen faced major setbacks in late 2024, with Japanese media reporting uncertainty over its future and partners struggling to secure backing for the next phase.

We moved quickly with allies, coordinating a snap action calling on the Victorian government to rule out further public funding, and we secured media coverage highlighting community opposition to pouring more money into coal projects.

With no new funding commitments announced since the pilot phase, HESC is now stalled indefinitely – a significant win for the alliance of groups who have been fighting this polluting coal project.

- Our community united in Gippsland to deliver a powerful and creative campaign showing Australia that we want clean energy solutions, not toxic nuclear.
- Our work pushed the Victorian Water Minister to review water pricing for coal mine rehabilitation, creating new opportunities for transparency and river restoration.







Electrify Victoria

We secured a world-leading gas phase-out plan for homes and commercial buildings, right here in Australia's most gas-dependent state.

Nation-leading electrification reform

In a major step forward for our climate, cost of living and renters' rights, the Victorian Government announced new building regulations – including phasing out gas hot water in homes from 2027, extending all-electric standards to most new buildings, and mandating minimum energy efficiency standards for rentals.

Since the launch of our Stop AGL campaign in 2018, our community has pushed methane gas onto the political agenda – on the streets, in the media, online, and in MP's offices.

This year we staged vibrant weeks of action, commissioned research highlighting the high costs of gas heating compared to electric alternatives and generated a wave of public submissions that made expert and community voices impossible to ignore.

To secure the strongest possible policy outcomes, we also worked closely with cross-sector allies, published research that drove positive media coverage, and mobilised our network to speak directly with their MPs.

Our 'How We Electrify' report received extensive coverage across print, digital, TV and radio – with standout stories in The Age, The Guardian and Yahoo – ensuring the case for electrification reached a wide audience.

We also released analysis commissioned from Springmount Advisory mapping out the huge number of jobs that will be created in each state electorate if we adopt a plan to electrify every Victorian home.

These reforms are a testament to our work and set a globally significant precedent, showing that large-scale, government-led electrification is achievable and that communities are ready to ditch gas.

Growing grassroots momentum

With community groups across Victoria already doing great work to electrify their neighbourhoods, we launched a new plan to make this grassroots action visible to local MPs.

We connected with electrification groups across the state and now have volunteers delivering a regular 'Electrify Victoria' newsletter to their State MPs, showcasing the scale and diversity of community-led efforts.

By making this momentum visible, we're ensuring local representatives see the support in their own electorates. We're also showing the Victorian Government that they can be confident rolling out their electrification reforms, as communities are already doing the work to support households in making the switch.

Healthy Rivers

In a pivotal election year, we engaged hundreds of thousands of voters and built momentum to reconnect rivers, protect wetlands and support First Peoples' water justice in the Murray-Darling Basin.

Holding the line in a high-stakes election

During the 2025 federal election, we worked with our allies in the Murray-Darling Conservation Alliance (MDCA) to keep rivers on the political agenda. We targeted two marginal seats in South Australia – where the Murray River is truly the state's lifeblood. We ran events, media campaigns, billboards and frontpage newspaper ads reaching hundreds of thousands of voters.

In an election dominated by cost-of-living concerns, no major party made a significant new commitment to river health. Nonetheless our polling showed we mobilised significant voter concern which creates a strong foundation for bold reform. In this term of government Federal Labor will oversee a historic review of the Basin Plan and Water Act, creating a rare moment of possibility. Our advocacy for stronger biodiversity and water justice outcomes will shape the debate over the year ahead.

Reconnecting Rivers

We continued our work to change rules that block water from flowing naturally into wetlands and floodplain forests. We cohosted events with birdwatching, environmental and Landcare groups across Victoria to spotlight local wetlands and sites like Gemmill Swamp on the lower Goulburn River.

These visits sparked local media, grew our network with new volunteer leaders, and showed how small changes in flows can make big differences for local wetlands. Across the southern Murray-Darling Basin, rule changes would let water flow to more than 370,000 ha of wetlands, about 7.5 times the size of Wilson's Prom. With the release of a new Commonwealth roadmap for these rule changes, we will continue advocating for strong state and federal action.

First Peoples' Water Justice

First Nations across the Basin continue to fight for water justice – and we've stood with them in solidarity. After years of delay, the federal government finally began purchasing water for cultural priorities. This is a step forward, but much more needs to be done to deliver justice in a water market worth at least \$30 billion.

This year we worked with the Murray Lower Darling Rivers Indigenous Nations (MLDRIN) to launch a powerful water justice video and petition. We also backed the Walk for Truth and the Yoorrook Justice Commission as they laid the groundwork for Treaty, helping to turn out thousands of supporters to rallies and events across Victoria.

People Power

This year our Action Network grew in diversity, leadership and reach – from engaging new communities to shaping the federal election and winning major clean energy commitments.

Building a Movement of Many

This past year we have made new connections and grown the cultural diversity of our Action Network. We have supported leadership on climate and environmental solutions from people who have traditionally been under-represented in the movement, with a particular focus in the western suburbs of Melbourne. Through 14 'table talk' events, we engaged 250 people across Chinese, Vietnamese, South Asian, Italian, Iraqi and Muslim communities.

Our "Movement of Many" report captured 13 individual stories that together celebrate the strength, wisdom, joy and creativity everyday Victorians bring to our big environmental challenges. Our hope is that by sharing these stories we can build a more united, representative, and effective climate and environment movement.

Growing our connections and capacity

Opportunities to build skills and connections continue to be a priority for the Action Network. This year we held our fourth annual Action Network Summit.

In June 2025, sixty people from across Victoria came together to learn, share and shape the future of our movement at the Winter Summit, held on the banks of the Latrobe River/Durt' Yowan. From first-time volunteers to long-time Action Network members, everyone brought something unique – and left with new skills, stronger relationships, and renewed energy to act.

Our incredible cohort of Local Organisers is growing with new leaders stepping up across the state including in the western and eastern suburbs of Melbourne.

Community organising delivers clean energy wins

During the federal election we worked with the Victorian Trades Hall Council and local environment groups to build support for household electrification and clean energy solutions.

Under the banner of the national 'Renew Australia for All' alliance, we worked across the federal seats of Chisholm, Deakin and Menzies, handing out thousands of flyers at train stations and helping to organise 3 candidate forums and 25 community engagement events. This work reached more than 5,000 people and our digital ads reached over 300,000 people.

Federal Labor responded to the alliance's efforts by announcing it would provide \$2.3 billion in rebates for household batteries, and all three seats we worked in were won by candidates with climate-friendly policies.

- Our federal election organising had a powerful impact, building relationships with local MPs and winning a big policy announcement on home batteries.
- Through 14 'table talk' events, we engaged 250 people across Chinese, Vietnamese, South Asian, Italian, Iraqi and Muslim communities.

First Nations Solidarity

Wherever we work, Environment Victoria is conscious that we are on First Nations lands and waters. Which is why, from the Murray-Darling to the Latrobe Valley, our campaigns work with Traditional Owners and First Nations communities to deliver environmentally just outcomes. We also recognise our responsibility to support First Nations to achieve land justice, address inequality and build power to make decisions about Country and culture.

In our Healthy Rivers campaign we've been working with First Nations to support their demands for water justice. In January we held a joint strategy session with peak body Murray Lower Darling Rivers Indigenous Networks (MLDRN) and large environment and grassroots groups to work out a shared approach for the upcoming Murray-Darling Basin Plan review.

We were also proud to answer the call from First Nations allies and the First Peoples' Assembly of Victoria (FPAV) to back in truth-telling and Treaty for Victoria. 2025 saw the finalisation of the Yoorrook Justice Comission, Victoria's truth-telling process, which was set up by the FPAV and the Victorian government to provide an official record of the impact of colonisation and ongoing injustices experienced by First Peoples in Victoria.

We promoted the findings of the Yoorrook Justice Commission on Land, Sky and Waters and supported the historic Walk for Truth which culminated in the delivery of the findings from Yoorrook to the Victorian Parliament.

Treaty is about First Nations communities having the right to determine their own future and to make decisions about their people, lands and waters. You can read about our commitment to Treaty in Environment Victoria's Friends of Treaty pledge on our website.

With a statewide Treaty expected to be finalised by the end of 2025, we worked with the First People's Assembly of Victoria (FPAV) to host a briefing for senior leaders of 15 organisations across the environment movement. Together we affirmed our commitment to supporting Treaty and many organisations went on to develop their own pledges. We also co-hosted a cross sector briefing with Victorian Trades Hall Council and the FPAV to lay the groundwork for grassroots engagement on Treaty. We've also been ensuring the Environment Victoria Action Network is ready to have powerful conversations about Treaty in their communities.





Media Coverage

Getting our messages and expert campaigners out into the media, including on radio, TV and newspapers, is one of the most effective tools we have to influence public debates and build our reputation.

Over the past year we achieved 880 media hits across television, radio, newspapers and online outlets. This coverage ensured that our messages were part of public debate and that decision-makers heard from the community and felt pressure to act.

As our volunteer Action Network grows, we're creating more opportunities for local voices to be heard. With training and support, volunteers are building visibility and credibility in their communities, helping important issues get cut through in local media. This was especially so in Gippsland, where our community organisers were regularly invited to speak on nuclear power, mine rehabilitation and clean energy.

Nationally, we helped inform conversations about the benefits of electrification, the transition away from gas appliances, and the federal election debate over nuclear energy. Our report 'How We Electrify' was a particular highlight. Developed in collaboration with Renew, it gained wide attention, including coverage in The Age, The Guardian and Yahoo, while our response to the Victorian government's gas appliance regulations highlighted the opportunities for households to save money and reduce pollution.

We also published several opinion pieces that helped shape the conversation — countering the gas industry's rhetoric in the Herald Sun, highlighting household savings from moving away from gas in The Fifth Estate, and outlining the case against nuclear energy in the Latrobe Valley Express.

Through this work, media engagement has helped us reach new audiences, broaden the conversation, and strengthen support for the changes needed to protect our climate and environment.

Our Governance

Environment Victoria Incorporated (referred to in this document as Environment Victoria) is an Incorporated Association under the Associations Incorporation Reform Act 2012 (Victoria) and is a Registered Charity under the Australian Charities and Not-for-profits Commission. The principal activities of Environment Victoria are to safeguard Victoria's environment through advocacy and education. As of June 30, 2025 we had 242,816 supporters, 5954 active cash donors, 4477 regular givers and 224 individual and group members.

The organisation is governed by a Board of Directors in line with the requirements of Environment Victoria's Rules of Incorporated Association. Directors are appointed by Environment Victoria members at the annual general meeting and are members themselves. Directors serve for a minimum two-year term and do not receive remuneration for their role but may receive reimbursement for out-of-pocket expenses.

Directors govern the organisation and retain ultimate authority over its management, delegating the day-to-day management to the Chief Executive Officer (CEO). The CEO's responsibilities are guided by an annual plan, performance criteria and monitoring adopted by the Board. The Board conducts an annual performance review of the CEO.

Environment Victoria is endorsed as a Deductible Gift Recipient (DGR) registered with the Australian Taxation Office enabling the receipt of taxdeductible gifts. It is covered by Item 1 of the table in section 30.15 of the Income Tax Assessment Act 1997. All donations received are used to support Environment Victoria's charitable objectives.

Role of the Board

The Board's primary role is the good governance of Environment Victoria, including the development and monitoring of long-term direction and goals and the strategies and policies needed to achieve these goals. The Board also appoints and manages the CEO and ensures that the organisation complies with its contractual, statutory and legal obligations; remains financially viable and proactively manages risks. The Board regularly engages with employees via strategy planning sessions, sub-committees, events and meetings. The Board also regularly invites senior staff to present key information to the Board, and the Directors are available to provide support and advice or receive feedback.

To meet our governance requirements, Board membership is diverse and includes key competencies such as environmental policy, strategy, finance, legal, fundraising, audit, risk, communications and engagement. The Board regularly reviews the skills necessary to undertake its activities and undertakes an appraisal of its performance annually.

The Board operates sub-committees to consider various issues in greater depth and make recommendations. The Board currently operates three sub-committees, with membership consisting primarily of Directors with support from coopted experts. The Board does not delegate its responsibilities to sub-committees.

This year the Board had a focus on optimising the financial management of the organisation, including strengthening forecasting, monitoring and reporting procedures and review and updating key organisational policies following last year's policy architecture overhaul.

Finance, Audit and Public Fund Committee

This committee assists the Board to fulfil its responsibilities for the financial reporting process, the system of internal controls, the audit process, the organisation's processes for monitoring compliance with laws and regulations and codes of conduct, and the organisation's processes for recognising, identifying and dealing with financial risks. This committee also oversees Environment Victoria's Public Fund, referred to as the Green Future Fund.

Fundraising, Communications and Engagement Committee

This committee provides advice to the Board on strategies to enhance the reputation and capacity of Environment Victoria and contributes to its long-term financial strength through leading the development of an effective revenue-raising strategy.

Governance Committee

This committee provides support to the Board on processes, policies, systems and frameworks that help maximise the efficiency, effectiveness and quality of Environment Victoria's work and the functioning of the Board. It also leads the oversight, management and performance of the CEO.

Directors' Report

Conor Costello | President, Fundraising, Communications and Engagement Committee member and Governance Committee member

Conor brings a breadth of experience in policy and advocacy, strategy and communications gained in the international development and government sectors. Our Financial Performance


In 2024-25, thanks to the wonderful generosity of our supporters, Environment Victoria was able to maintain its financial security and independence. Our fundraising appeals reached hundreds of thousands of people in Victoria through mail, email and social media, generating both funds and increasing the profile of our campaigns across large audiences and platforms.

Environment Victoria's total income increased this year from \$4.16 million in 2023-2024 to \$5.51 million, including investment income from our endowment fund of \$217,532. This increase is mostly the result of higher funding from philanthropic partnerships including \$425k funding for the establishment of the Murray-Darling Conservation Alliance (MDCA). The expenses for the current year were \$5.45 million and we reported a surplus of \$60,932 reflecting our ongoing investment in our regular giving program, funding for MDCA of \$553k in addition to growth in our environment campaigns during a Federal election year.

For 2025-2026 the Board has approved a budget deficit of \$356k which includes finalising our contribution to the setup of MDCA after which it will be self-sufficient. This deficit is forecast to return to surplus in FY27 and will ensure Environment Victoria is able to continue growing it's reach and impact.

Environment Victoria now has \$1.37 million in reserves, including \$1.09 million in the Green Future Fund, a donor funded endowment that underpins our ability to take on the most pressing campaigns and speak without fear or favour.

\$2.60 million of our income was spent on our environment campaigning and programs, \$1.99 million was invested in raising funds and growing our supporter base including \$0.23 million invested in a regular giving growth program, and \$0.84 million was spent on essential administration and organisational leadership.

Former Director of the Prince Henry's Institute of Medical Research and Head of Endocrinology at Monash Medical Centre, Henry Burger was a passionate member of the Environment Victoria community for almost 15 years, until he sadly passed away in 2024.

And, in 2023, Henry and Jenny provided visionary support to helping Environment Victoria establish a national campaign to restore the Murray-Darling back to health.

Our condolences go out to Jenny, his life-partner of 65 years, their five children, grandchildren and the countless people whose lives Henry touched through his clinical practice and research into women's health, menopause, fertility and infertility.





The Green Future Fund

Environment Victoria's Green Future Fund underpins our financial stability. It provides a long-term investment plan to safeguard Victoria's environment by accepting donations and bequests today and investing them for the future.

The Green Future Fund was set up in 2010 at the request of a generous, life-long supporter and friend: Anne Kantor. Anne's wish was for Environment Victoria to use her \$2 million gift to create long-term stability for the organisation she cared about.

Together we created a 20-year plan for the Green Future Fund, with income generated from this investment, plus regular drawdowns from the balance as Anne requested.

Thanks to Anne's visionary support, we have had the power to take on the biggest environment and climate challenges of today, and the future.

Along with other significant distributions over the lifetime of the fund, as at 30 June 2025 the Green Future Fund held investments to the value of \$1.1 million.

The Green Future Fund is overseen by a subcommittee of the Board of Environment Victoria and is invested in a portfolio managed by Ethical Investment Services. The investment managers operate under an ethical investment overlay (which excludes investments in fossil fuel companies, for example), and the Board monitors ongoing compliance with that ethical overlay.
